A fee of \$40.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete, or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

Trial Information- Notice to Exhibitors

Novice A is open to any handler that has not earned a nosework title in any organization and is not a nosework judge or instructor. Handlers are only allowed to run 1 dog per element (Example 1 dog in novice and 1 in advanced).

A UKC registration number is required to participate in these trials. www.ukcdogs.com for more info.

There will be no food available for sale at this trial – Come prepared for yourself and your canine partner.

From Interstate 35 (Exit 89) Corporate Woods Drive Exit. Go East on Corporate Woods Drive, which becomes NE 62nd Ave (Approx. 1 ½ Miles) Turn Right South) on NE Berwick Dr. (by the Berwick Cemetery) (Approx. ½ mile) Turn Left (East) on NE 58th Avenue. Property is on the left (North) – Look for large blue building East of yellow building.
