Trial Limit- 125 runs per day total all events

Show Hours—Friday 11:00 a.m. to the end of the trial. Judge's briefing not before 12:00 pm, with trials to follow. Saturday 8:00 am to end of the trial. Judge's briefing not before 8:30 am with trial to follow.

Pre-entries will **open March** 7, 2022 and will **close Monday**, April 4, 2022 or when entry limits have been met. A wait list will be kept if trial fills. Confirmation of entry will be sent after pre-entries are closed. Day of Entries will close day of trial at 11:00 am on Friday and 8:00 am on Saturday, or when entry limits have been reached, at which time entries cannot be accepted, canceled, altered or substituted except as described in UKC Dog Show Rules

A fee of \$40.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

Directions to Mikel Property: From Interstate 35 1) Take Corporate Woods Drive Exit (#93 in Ankeny) 2) Go East on Corporate Woods Drive, which becomes NE 62nd Avenue, approx. 1 ¹/₂ miles 3) Turn right (South) on NE Berwick Dr., approx. ¹/₂ mile (by the Berwick Cemetery) 4) Turn Left on NE 58th Avenue. Property is on the left (look for large blue building East of yellow building)

Handlers are only allowed to run 1 dog per Element level. (Example 1 dog in novice and 1 in advanced).
