Day of show entry cut off 8:00 am. Judge's briefing not before 8:30 am each day, with trial to start at 9:00 am.  
Containers followed by Exteriors.

Pre-entries will **open Monday, March 2, 2020** and will **close Monday, March 30, 2020** or when entry limits have been met. A wait list will be kept if trial fills. **Confirmation of entry will be sent after pre-entries are closed.**  
Day of Entries will close day of trial at 8:00 am on Saturday and Sunday, or when entry limits have been reached, at which time entries cannot be accepted, canceled, altered or substituted except as described in UKC Dog Show Rules

A fee of \$40.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

**Trial Information- Notice to Exhibitors**

Novice A is open to any handler that has not earned a nosework title in any organization and is not a nosework judge or instructor. Handlers are only allowed to run 1 dog per element (Example 1 dog in novice and 1 in advanced).

A UKC registration number is required to participate in these trials.

**Awards and Prizes:**

Placement ribbons will be provided for 1-4 placements in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score. New title ribbons will be offered for anyone earning titles.

**Directions to Facility: Physical address: 29513 R Avenue, Adel, IA**

**From the North or South:** Interstate 35/80 to the Hickman Road exit (US Highway 6, exit 125). West approximately 10 miles to County Road R-16. South (left) on R-16 ¼ mile. Training Center is on the right.

**From the East or West:** US Highway 6 to County Road R-16 (approximately 10 miles West of the Interstate 35/80 bridge), then South ¼ mile. Or, Interstate 80 to Van Meter exit (#113) then North 4 miles. Seelah is on the left before reaching US Highway 6.

Additionally, exhibitors are required by State of Iowa health regulations to maintain proof of rabies vaccination.
