Day of Entries will close day of trial at 7:45 a.m. on Saturday and Sunday, or when entry limits have been reached, at which time entries cannot be accepted, canceled, altered or substituted except as provided for in UKC Dog Show Rules

A fee of \$40.00 will be levied for a returned check . All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. FAX'd entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

### **Trial Information- Notice to Exhibitors**

A UKC PT or NACSW ORT is required for entry in a UKC element title trial for the level/odored entered. Copy of PT or ORT should be sent with entry.

For pre-entries if you do not pass the required PT test in the morning the club will refund you the entry fees that were pre-paid. This is to encourage pre-entries.

Novice A is open to any handler that has not earned a nosework title in any organization and is not a nosework judge or nosework instructor.

Handlers are only allowed to run 1 dog per PT or Element level. (Example 1 dog in novice and 1 in advanced).

A UKC registration number is required to participate in these trials. For information on UKC registration go to [www.ukcdogs.com](http://www.ukcdogs.com).

Crating space will be available indoors. Some food will be available for purchase onsite.

### Awards and Prizes:

Placement ribbons will be provided for 1-4 placements in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score. Ribbon will be provided for High in Trial each trial and High Junior. New title ribbons will be offered for anyone earning titles.

1. Nosework trials will include a pre-trial for the levels being run. Dogs need to pass the pre-trial for the level they are competing in. Dogs may be entered prior to passing, but must pass the pre-trial prior to competing that day. If the dog has passed on ORT in the applicable odor please submit a copy of proof.
2. Individual element classes are divided into Levels "N" - "E" and further divided into "A" and "B" sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
3. Full Nosework Trials are divided into Levels "N" - "E" and further divided into "A" and "B" sections depending on the experience of the dog and/or handler. These trials contain all four elements. Each element passed earns a leg toward a title in that element.
4. Handler Discrimination. One glove will be used and must be provided by the handler.
5. All entries must be submitted on the current "Official UKC® Nosework Trial Entry Form".
6. Use a separate entry form for each dog entered in a club's event.
7. Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/Limited Privilege number/Permanent Registration/Temporary Listing.
8. We want you to keep the points earned at UKC Licensed events. Important things to remember:
  - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
  - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at [www.ukcdogs.com](http://www.ukcdogs.com) or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
  - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
